PURPOSE

It is ideal for golf courses and parks. Under normal conditions, the product lasts up to 90 days, Reapplication is recommended after a precipitation event.

BROADCAST TREATMENT

Use an agricultural pump sprayer or agricultural electrostatic sprayer to apply over the soil and turf you wish to protect.

PERIMETER/BARRIER TREATMENT

For perimeter and barrier protection, extend out 25 feet from the nuisance-attracting structure.

COVERAGE

Mix 2 US ounces of LUMI (dry weight) with 5 gallons of water for every 10,860 square feet of coverage area. Apply every four weeks to ensure maximum protection. It is advisable to reapply after significant or frequent rain events.

FOR BEST RESULTS:

(STORAGE & HANDLING)

Store between 40 F and 85 F in a dark place protected from direct sunlight or high heat.

Do not allow moisture to come in contact with the product that is not being used. If clumping exists, break it into useable chunks. The product is still usable and will mix readily with water.

Between uses: close the zip lock seal on the pouch completely and then squeeze all excess air out through one-way valve to avoid clumping. Keep away from children. Do not inhale. Use only as directed.
